#### **Editorial:**

Now a days, colleges and Universities are utilizing 'social media platforms' to communicate with the students. #### 50 years of Kesavananda Bharati Verdict – A Tribute to Constitutional Supremacy

A case which started as merely a case on land reforms, lead to questioning the power of the parliament to amend the basic structure of the constitution. It was a wonderful journey to talk about. It is the description of the land mark case in the history of Indian Judiciary ever filed on constitutional supremacy, i.e., Kesavananda Bharati case. Kesavananda Bharati vs State of Kerala is a landmark case in the constitutional and legal history of India, which provided a definite answer to the issue of whether the power of the Parliament to amend the Constitution is absolute and unqualified. The decision in Kesavananda Bharati case laid down the "basic structure doctrine" of the Indian Constitution. Kesavananda Bharati v State of Kerala case holds immense significance for several reasons, one of them being that it was heard by the largest-ever bench constituted by the Supreme Court of India, comprising thirteen judges of the Supreme Court.

Kesavananda Bharati was the chief of Edneer Mutt which is a religious sect in Kasaragod District of Kerala. Kesavananda Bharti had certain pieces of land, which were owned in his name. The state government of Kerala introduced the Land Reforms Amendment Act, 1969. According to the act, the government was entitled to acquire some of the Mutt's land of which Kesavananda Bharti was the chief.

On 21st March 1970, Kesavananda Bharti moved to Supreme Court under Article 32 of the Indian Constitution for enforcement of his rights which guaranteed under Article 25 (Right to practice and propagate religion), Article 26 (Right to manage religious affairs), Article 14 (Right to equality), Article 19(1)(f) (freedom to acquire property), Article 31 (Compulsory Acquisition of Property). When the petition was still under consideration by the court, the Kerala Government passed another act i.e. Kerala Land Reforms (Amendment) Act, 1971.

As a part of kesavananda Bharati case majorly three issues were put infront of the Supreme court for its comment. 1. Whether the 24th Constitutional (Amendment), Act 1971 is Constitutionally valid or not? 2. Whether the 25th Constitutional (Amendment), Act 1972 is Constitutionally valid or not? 3. The extent to which the Parliament can exercise its power to amend the Constitution.

It was held by the apex court by a majority of 7:6 that Parliament can amend any provision of the Constitution to fulfil its socio-economic obligations guaranteed to the citizens under the Preamble, subject to the condition that such amendments won't change the basic structure of the Indian Constitution. It was laid down by the court that the Doctrine of Basic Structure is to be followed by the Parliament while amending the provisions of the Constitution. This is later popularized as Basic Structure Doctrine.

#### What is the meaning of Basic Structure?

Basic structure means, basic features of the Constitution without which our Constitution will be left spiritless and lose its very essence. The basic structure of the Constitution was not mentioned by the bench and was left to the interpretation of the courts. The Courts need to see and interpret if a particular amendment violates the basic structure of our Indian Constitution or not.

#### **Significance of the Judgment**

The majority of the Bench wanted to preserve the Indian Constitution by protecting the basic features of the Constitution. The judgment was given after analyzing the various aspects and was based on sound reasoning. The Bench feared that if the Parliament is provided with unlimited power to amend our Indian Constitution, then the power will be misused and would be changed by the Government according to its own will and preferences. The basic features and the very spirit of the Constitution can be altered by the Government if they have unlimited powers to make amendments. There was a need for a doctrine to preserve the rights of both Parliament and citizens; therefore, the Bench came up with a middle path to protect both their rights through the doctrine of Basic Structure. Despite the huge number of amendments, the spirit, and ideas of the framers of the Indian Constitution have remained intact. Indian Constitution did not lose its identity and spirit because of the decision taken by the Bench in this case. The landmark case of Kesavananda Bharti provided stability to the Constitution. Though the petitioner lost his case partially, yet the judgment that was given by the Bench, in this case, worked out to be a savior of Indian democracy and saved the Constitution from losing its spirit.

#### Conclusion

Though, over the decades, the basic structure doctrine has been criticized repeatedly — for diluting the principle of separation of powers and undermining the sovereignty of Parliament, and as a vague and subjective form of judicial review, still it has been placed in the top verdicts of Indian Judiciary and became a torchbearer for many further judgments in crucial cases. No doubt it created awareness among the public about Fundamental Rights, Private property, Parliament's power over constitution and the concept of judicial review, and above all, these concepts were debated widely among the public. As this historical verdict completes its 50 years by 24-04-2023 (verdict was given on 24-04-1973), the decision of Supreme court of India to create a new webpage to avail all the details, arguments, written documents and judgement copies related to the case for the reference of general public, researchers, advocates, and foreign scholars etc is really admiring and welcoming.
